## **INVITATION FOR BIDS**

### **TENDER FOR THE RE-CONSTRUCTION OF THE BOUNDARY WALL FENCE AT NORAD MAIN DEPOT IN KASAMA DISTRICT - FRA/W/02/20**

The Food Reserve Agency (FRA) has budgeted for the re-construction of the boundary wall fence at Norad Main Depot in Kasama District.

The Agency now invites sealed bids from eligible contractors. The tender is open to firms that are registered in Zambia as contractors with the National Council for Construction (NCC) in **Category B or C, Grade 5**.

The scope of work includes, but is not limited to the following:

- (a) Earth works;
- (b) Concrete and block works; and
- (c) Drainage works.
